

# Rental Agreement For The Mandeville House

**Under the following terms and conditions, it is understood that the home will be used as a family rental only. NO PETS OR HOUSE PARTIES.**

## Payment

- For this rental period, I agree to pay a rental fee of \$\_\_\_\_\_ (Rental Amount), **no later than 60 days** prior to the commencement date of the rental period. Failure to pay in full within this time frame may result in cancellation of reservation
- I agree to pay a security deposit of \$300. The security deposit will be refunded 7 days from termination of this contract provided that Tenant abides by all terms of this contract
- The property will not be reserved until either the security deposit and/or rental fee are paid

## Cancellation Policy

- **There will be no cancellations due to weather**
- If you cancel your reservation 60 days or less before the first night of your stay, you will forfeit your entire \$300 Reservation / Security deposit. We will refund your lodging payment if we can rebook your cancelled dates
- If you cancel your reservation more than 60 days before check-in, there is a \$100 cancellation fee, which will be deducted from your Reservation / Security deposit refund
- The first day of the rental, there will be no refunds for any reason
- No credit will be given for shortened stays due to late arrival or early departure for any reason

- There is no loss of deposit if you cancel and immediately rebook your stay. Re-bookings must be paid in advance and are non-refundable

#### Hurricane Policy

#### Damaged / Broken Items

- I agree to report any damaged / broken items, appliances, etc immediately
- I understand that there can be no guarantee that any particular item, appliance, etc, will be in full working order for the duration of my stay
- I agree not to ask for any type of refund if every *reasonable* effort is made to repair / replace anything I report as damaged or broken

#### General Conditions

- I agree to have no more than **six (6)** people for occupancy
- This agreement shall not be assigned, nor the premises sublet without the written consent of the owner or his agents
- I will maintain this property in as good condition as I find it and agree to replace or pay for any loss, breakage or damage to the satisfaction of the owner or agents
- **I understand that this is a non-smoking rental.** I am permitted to smoke outside, provided I do not leave butts in the yard. I agree that any violation of the smoking policy will incur a forfeiture of my entire security deposit
- It is expressly understood and agreed that owner of said premises will not be liable for any damages or injury to tenant or other occupants and their property from whatever cause arising from the occupancy of said premises
- I agree not to hold the owners responsible for any Items that I leave behind, or are stolen
- I agree to vacate said premises upon the termination of this agreement at the hour and date shown above. Before vacating, I will:

- Place all dirty towels in the bathtubs. The beds should be left unmade. Sheets do not need to be stripped from the bed
- Clean all dirty dishes and put them in the proper place in the cabinets
- Remove all perishables and food items from the refrigerator
- Collect all garbage and place outside in the trash can
- Set the thermostat to 79° when A/C is on, 65° when heat is on
- Turn off all lights and appliances
- Close and lock the premises

Right Of Entry

- I agree that the LANDLORD or his AGENT shall have the right to enter into the premises, or any part thereof, for the purpose of examining the same or making repairs or alterations deemed necessary

**I have read and understand the terms of this rental agreement. I agree that if they are not abided by, the owner may deduct the necessary costs from the security deposit. I also certify that I am at least 21 years of age and that I will be held responsible for the care of this property being rented under my name. I accept full responsibility for any damages or extra cleaning charges, should they be discovered during or after my departure.**

When signed by the tenant and accepted by owner, this shall constitute a rental agreement.
